Who we are

The EUHA is the specialist association of hearing aid acousticians. Its members endorse high trade-specific standards for their profession. For more than 55 years, we have championed qualified care and supply for people with impaired hearing. Founded in 1960 as the Union of Hearing Aid Acousticians (UHA), our association was renamed European Union of Hearing Aid Acousticians (EUHA) in 2004. At the beginning of 2017, the German name of the organisation changed to Europäische Union der Hörakustiker e. V., reflecting the new name of the German job title, *Hörakustiker*. Our members are involved in hearing protection, hearing prevention, hearing improvement, hearing rehabilitation, and hearing research – fields in which every acoustician should remain up to scratch after completing their initial training.

What we want

The EUHA offers a networking platform for hearing aid acousticians, academics and laymen with an interest in trade-specific issues. With the aim of providing best possible care for those with impaired hearing, the EUHA offers first-class further education and advanced vocational training, engages in development work, and in its guidelines and statements launches standards and recommendations. As the oldest and largest association of hearing aid acousticians in Europe, the EUHA wishes to represent its members across Europe. The EUHA campaigns for responsible professional ethos and professional honour, working together with numerous educational institutions as well as with academics and technicians. EUHA membership is a matter of course for every acoustician working to high professional standards.

What we do

Participation

We give our line of business a face, strengthen the acousticians' profession, and are eager to raise new issues and ideas. EUHA members are encouraged to actively get involved by contributing lectures to our regional conferences, technical seminars, workshop and tutorial sessions, courses, and our Congress.

Further education and advanced vocational training, qualification

Since 1960, the EUHA has been the organiser of the International Congress of Hearing Aid Acousticians, offering a chance for delegates to exchange information at courses, workshop and tutorial sessions, and round table talks. Technical seminars, regional conferences, and local meetings are offered to broaden specialist knowledge. These conventions are held in different locations across Germany to provide the latest news from our line of business with a view to practical application. The EUHA also offers regular training in audio therapy, and launches interdisciplinary expert groups, e. g. its Audiology Expert Group.

Expert groups and guidelines

The EUHA currently runs expert groups on audio therapy, the EUHA sponsorship award, earmoulds, hearing protection, and audiology. Members of the expert groups are working on issues such as setting and assessing assistive listening devices, frequency compression, loudness scaling, or hearing aid parameters. They also deal with custom-made earmoulds for hearing protection and hearing protection for hearing aid users as well as different approaches in audio therapy. So far, two guidelines each on percentile analysis and hearing protection have been drawn up as well as two guidelines on calibrating and checking the test box. Moreover, every year, results of the latest undergraduate research are evaluated.

Support for young talents

In 2010, the association introduced its EUHA Sponsorship Award to support young talents. Ever since, the EUHA has maintained a dialogue with sponsorship awardees, thus keeping up with the latest trends. The innovative findings are published on the EUHA website.
